Requisition #56834 in the amount of \$45,000.00 as requested by General Counsel for Fisher Development Strategies. - a) Req # 59425 in the amount of \$150,697.02 as requested by CIO Lawless to purchase Black Box Network Services (telephone handsets) to complete the implementation of the new VOIP phone system. This equipment will be used throughout the “west” campus buildings and offices. This is Phase III of III for this project. The Board of Trustees has previously approved \$523,560.81 for this project. - b) Req # 59505 in the amount of \$151,642.16 as requested by VP Muscarella for the removal of lead-based paint and repainting of four (4) campus houses. A total of \$79,642.16 has been expended for this commodity or service this fiscal year not including this proposed expenditure.)

Failure to maintain services can result in costly problems for the College. (This is a *cumulative* fiscal year expenditure.
