BOARD OF TRUSTEES' MINUTES

Meeting of November 8, 2022

The six hundred fifty-ninth meeting of the Board of Trustees was held on Tuesday, November 8, 2022 on the eleventh floor of the Administrative Tower. The meeting was called to order by Vice Chair Weiss at 6:18 p.m. followed by a salute to the flag.

Vice Chair Weiss requested a motion that pursuant to Section 105 of the Open Meetings Law of the State of New York, the Board of Trustees shall enter Executive Session for the purpose of reviewing the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation. Trustee Durso moved the motion; seconded by Trustee Siberón. Motion carried 6-0.

Chair Gardyn resumed the open meeting at 7:25 p.m.

Executive Session

The Board voted in executive session on the employment of a particular individual. The vote was unanimous by all Trustees present.

1. Approval of Minutes

Chair Gardyn requested a motion to approve the minutes of October 11, 2022. Trustee Weiss moved the motion; seconded by Trustee Durso. Motion carried 7-0.

Chair Gardyn requested a motion to approve the minutes of October 25, 2022. Trustee Durso moved the motion; seconded by Trustee Weiss. Motion carried 7-0.

2. Trustee Patel introduced the following resolution:

RESOLVED, upon the recommendation of the Nassau Community College Board of Trustees Finance and Capital Committee, the Nassau Community College Board of Trustees hereby approves the pending college procurement agreement with Via Evaluation in the amount of \$95,031.00, as requested by Acting VP for Institutional Advancement. (**FUNDING SOURCE: OPERATING**)

Chair Gardyn requested a motion to consider this item. Trustee D'Agostino moved the motion; seconded by Trustee Durso. Motion carried 7-0.

3. First Reading and Discussion of Policy 5300

Trustee Weiss stated the purpose of this policy is to set out the immunization requirements for College students and to outline the responsibilities of the Student Health Office in ensuring the College's compliance with applicable health laws and regulations.

Trustee Rosenberg claims that the policy is in violation of peoples' constitutional right to choose not to take vaccines or medicines and the concept "my body, my right" for other issues, should be the same philosophy applied for vaccines. He added that individuals who received the vaccine still contracted COVID-19. Chair Gardyn remarked, as the only physician seated on the Board, the COVID-19 vaccine had one and only one purpose: to build antibodies. Vaccination does not ensure prevention of infection but makes us all less susceptible to fatality.

It is Trustee Rosenberg's belief that mandating vaccinations at this late stage would only exacerbate dwindling enrollment, as students who uphold their stated right not to take the vaccine will not be able to attend college. He added, it should be up to each individual to decide whether to get vaccinated, not the government.

Chair Gardyn proffered that hopefully the COVID-19 pandemic will end with a resolution similar to that for polio, small pox, and measles. Trustee Rosenberg objected that the analogy is not scientifically sound, because polio is not contagious if you've been vaccinated, and a better comparison would be the flu shot, which is more effective than the COVID-19 vaccine but not mandated.

Trustee Weiss reminded the Trustees that the vote will take place at the next Board meeting.

Dr. Conzatti certified that she reviewed Policy 5300 and that it was submitted for consultation to the appropriate constituencies within the College before submission to the Board.

Chair Gardyn made a motion under Article VIII section C(6) of the Rules of Procedure to allow for the consideration of an item that did not appear on the Calendar. Trustee Weiss seconded the motion. Motion carried 7-0.

4. Trustee Weiss introduced the following resolution:

BE IT RESOLVED that the Board of Trustees hereby authorizes the Interim President of the College and the Chair of the Board of Trustees to execute the separation agreement and general release to cause the implementation of the terms set forth therein, and be it further

RESOLVED that the Board of Trustees accepts the irrevocable letter of resignation of the employee who is the subject of said agreement, subject to receipt by counsel to the College of a letter of resignation.

Chair Gardyn requested a motion to consider this item. Trustee Durso moved the motion; seconded by Trustee D'Agostino. Motion carried 7-0.

Dr. Conzatti reported on the following items:

• NCC held its first formal Homecoming and Alumni Day on Saturday, November 5 at Mitchel Field Athletic Complex. NC Executive Bruce Blakeman, Police Commissioner Patrick Ryder, a graduate of NCC and an adjunct professor, Trustees Siberón and Patel, and approximately 800 students, alumni, staff, faculty, and administrators were in attendance.
