Projects in progress

- Fire Alarm Upgrade – South, H and Bradley have been encumbered by the County
- Security System Upgrade – Continuing installation of additional cameras/access control
- Portico Restoration – N and S Buildings to be completed next summer
- Natural Gas Conversions – North Hall and V Building next on next schedule after winter
- Master Plan Update/Infrastructure Assessment – Work started on F Cluster ramp repair
- Faculty Development Center (T-154) – Working on solution to building foundation issues
- Interior Signage G Building – Complete; CCB awaiting available funding
- Respiratory Care Laboratory – Making good progress, completion this spring
- Mitchel AFB NCO Club Building – Demo work nearly complete, roof restoration being designed
- LED tube installation – Replacement of 27,000 tubes in progress with in-house labor

Projects in design/planning

- Parking lot improvements, Phase 3 – Design progressing, first segment planned for 2017
- C Cluster Renovation – AE terminated, new AE starting to review existing plans
- Library Renovation – Master Space Plan submitted by Cannon to NCC/working on Phase 1 RFP
- Renovation of Tower Lobby – Location for new Art Gallery, work to start in mid-May
- Transfer of Mitchel AFB Theater – Awaiting confirmation of County offer on exchange
- Renovation of all remaining elevators – Design 90% complete, bid package out in June
- Renovation of Brick Cafeteria – AE working on design with Center for Students with Disabilities
- Building K & Bradley Hall window replacement – Project to proceed this summer
- North & South Halls ADA Ramps – Contract award being processed, construction start this summer
- Renovation of A&P labs – To be completed during the summer 2017
- Reprogramming of Tower vacant space – Design in progress
- Nassau County Police Academy – County DPW expects to bid in May 2017
