#### **BOARD OF TRUSTEES' MINUTES**

Meeting of April 17, 2023

The six hundred sixty-fifth meeting of the Board of Trustees was held on Monday, April 17, 2023 on the eleventh floor of the Administrative Tower. The meeting was called to order by Chair Gardyn at 5:20 p.m. followed by a salute to the flag.

Chair Gardyn requested a motion that pursuant to Section 105 of the Open Meetings Law of the State of New York, the Board of Trustees shall enter Executive Session for the purposes: 1) to discuss matters relating to negotiations involving the NCCFT; 2) to discuss the proposed acquisition, sale or lease of real property or the proposed acquisition of securities, or sale or exchange of securities held by such public body, but only when publicity would substantially affect the value thereof and 3) to review the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation. Trustee Patel moved the motion; seconded by Trustee Weiss. Motion carried 7-0.

## 1. Approval of Minutes

**WHEREAS,** NYU Langone has requested that discussions occur with Nassau Community College regarding the building of facilities on the campus of Nassau Community College;

**WHEREAS,** the College and Board of Trustees are interested in exploring the possibility of such occurrence, which is seen as being beneficial to the College, students and administration as well as NYU Langone and the community;

**NOW, THEREFORE, BE IT RESOLVED**, that the Nassau Community College Board of Trustees authorizes the president and/or her representative to enter into discussions with the NYU Langone regarding the location and details of the project and;

**BE IT FURTHER RESOLVED** that any further agreement between the College and the NYU Langone has to be reviewed and accepted by the College Board of Trustees.

Chair Gardyn requested a motion to consider this item. Trustee Patel moved the motion; seconded by Trustee Durso. Motion carried 7-0.

Trustee Weiss remarked on the positive opportunities partnering with NYU Langone will provide for our students in the Allied Health professions.

Dr. Conzatti reported on the following items:

### **Enrollment**

- Application numbers for both freshmen and transfers are significantly higher than those from last year. We are still in the process of testing many of our new students. We continue to communicate with this population by phone, email, and texting.
- Last week, the admissions office hosted two in-person student information sessions for admitted students and their families. We had 54 students attend the Wednesday session, and 61 students attend the Friday session. Offices that participated were Academic Advisement, Athletics, Dean of Students, Financial Aid, the Honors Program, Student Financial Affairs, and Student Personnel Services. This was the first time in more than 8 years we hosted an admissions event for newly admitted students, and the feedback was very positive. Thanked all who were involved.

Due to the event last week, we are assessing our communications plan, educational programs, and other measures to protect the safety and well-being of the campus community. Lockdown procedures are currently underway across campus.

Trustee Weiss reported that she had the privilege to attend the Annual Honor's Colloquium on April 4, 2023 and was impressed with the students who presented. She thanked the Honors Program Coordinators George Frost, Elizabeth Hynes-Musnisky, and Virginia Hromulak for an event well done.

### **Speakers**

Thomas O'Beirne, Counselor, Admissions Office, commented on the success of the Admissions Admitted Students events, section 36-5 of the NCCFT full-time faculty contract, and contract negotiations for which the Board wants the faculty to agree to a two-year contract that includes no raise in year 1, 1% in year 2, and paying 20% of health insurance costs.

Allison Bremmer, Professor of English, addressed the Board on the decisions regarding contract negotiations and the effects of these decisions on faculty and students, and assessed the style of leadership of the Board and Administration.

Suzanne Kaebnick, NCCFT Secretary/Professor of English, asked the Board to support a fair contract and to immediately end section 36-5 of the NCCFT full-time faculty contract.

Mary Lannon, Professor of English, spoke of the value and dedication of the faculty to students and asked the Board to rescind the unnegotiated enactment of section 36.5 of the NCCFT contract.

Faren Siminoff, NCCFT President, addressed the Board, stating that she hopes the Board listened to what her colleagues had to say. She pleaded with the Trustees to stop inflicting financial burden on this dedicated faculty and to rescind section 36.5 of the NCCFT contract when they enter executive session.

Ariel Lann, NCC Student, addressed the Board with her displeasure that it has been an entire year without a contract for the full-time professors, and about the financial burden of section 36.5 of the NCCFT contract and

the College not receiving an increase in funding for 15 years, and demands the five candidates put forth by the search committee be considered.

David Stern, NCCFT VP Classroom Faculty, asked the Board and pleaded to Trustee Durso to introduce the resolution Prof. Stern drafted to end the section 36-5 paycheck cut which has caused severe stress for the faculty and which is impacting our students.

Tracyann Ayala, Professor of Finance & Economics Dept., congratulated Trustee Patel for being a recipient of the SUNY Chancellor Awards, spoke of the burden of section 36.5 of the NCCFT contract, and implored the Board to add faculty promotions and tenure to the agenda for the May meeting.

Virginia Sanchioli, Biology Technical Assistant, cited the low morale on campus due to the decision to enact section 36.5 of the NCCFT contract and pleaded with the Board to reconsider this decision.

Chair Gardyn announced the next Board of Trustees' Committee meetings are scheduled for Tuesday, May 9, 2023 at 5:00 p.m. It is anticipated the Board will open the public session between 6:15 and 6:30 p.m.

Chair Gardyn requested a motion to adjourn the meeting. Trustee Durso moved the motion; seconded by Trustee Weiss. Motion carried 7-0.

Meeting adjourned at 8:15 p.m.
