



# NON-DEGREE SEEKING APPLICATION INSTRUCTIONS

Please read this information carefully before completing the form

## SUBMIT TO REGISTRAR

Non-Degree Students are those who do not intend to pursue a degree or certificate at NCC but rather, plan to take courses for personal enrichment, for transfer to another college or professional growth. They are not eligible for state, federal financial or loan programs.

## Requirements for Non-Degree Admission: In order to be considered for admission as a Non-Degree Student, you are required to:

1. Complete the application for Non-Degree Seeking Students
2. Submit proof of graduation from either an accredited High School or College
3. Pay the appropriate application fee

**Photo Identification:** Students are required to present photographic identification when receiving services from the Office of the Registrar.

## Deadlines

Completed applications will be processed on a first-come, first-served basis. Nassau Community College reserves the right to close admission at any time. Do not delay the application process. You must submit: proof of High School graduation and/or completion of a college degree. Non-Degree students are not required to take the College's Placement Tests; however, students who have not taken the College's Placement Test will be prohibited from enrolling in many college-level courses. NOTE: Mailed or faxed applications are accepted only up to six (6) weeks prior to the posted deadlines. ## Immunization Requirement

New York State Public Health law requires that all students attending college in the state who were born on or after January 1, 1957 and who are enrolled for 6 or more chargeable contact hours file with the College proof of immunization against measles, mumps, and rubella. ALL students, regardless of age who are enrolled for six or more credit hours, must fill out the meningitis survey which is available at the Student Health Services. Failure to comply with this law within 30 days from the start of the semester will result in a student's disenrollment from classes, without refund of tuition and fees. ## Residency Requirements

To be eligible for the resident tuition rate, a student must have one year's legal residency in New York State and six months in the County of Nassau. The legal residency of unmarried students under 21 is deemed to be that of their parents. New York State students from counties other than Nassau may have the non-residency tuition rate waived by submitting a Certificate of Residency from their home county fiscal office prior to payment of tuition and fees. The submission of a valid Certificate of Residency qualifies students who reside in counties other than Nassau for the Nassau County resident tuition rate. Applications for a Certificate of Residency are available in the Bursar's Office, Student Financial Affairs or the information Desk in the Student Services Center. For students commencing study in the fall semester, the certificate will cover a full year, including fall and spring semesters and summer sessions. Certificates of Residency must be renewed each year. Students with (F1) visas do not qualify for in-state tuition. Individuals on certain visas may qualify for in-state tuition and Certificate of Residency.

## Disciplinary Dismissals

If you have been dismissed from another college, you must ask for a Request for Admissions Review Committee form available in the Registrar's Office. In order for the College to make a decision, all supporting documentation regarding your individual situation should be submitted along with your application within thirty (30) of the start of the semester. Documentation provided later will only further delay your admittance to the college. If the committee does not meet before the semester begins, you will need to wait for the College's decision and postpone attendance until the following term.

## To Become a Degree-Seeking Student

Once registered as a non-degree student and you wish to change to Degree-Seeking (matriculated status) you must submit to the Office of the Registrar WITHIN the refund period of the full semester. 1) Official High School and College/University transcripts, 2) Change of Program form from the department in which you wish to major 3) comply with the College's Placement Test requirements unless a permanent exemption from the applicable area of the placement test can be granted based on documentation provided. 4) If you have international university/college credentials from outside of the U.S., submit an evaluation by professional evaluation company that is a member of AACRAO, NAFSA, NACES, AICE, ATA and Better Business Bureau (i.e. World Education Service, AACRAO etc.)

\*\*Students interested in only studying English through the Language Immersion Program at NCC (LINCC) will be required to take the placement test in English and reading. Students in this program are not eligible for financial aid. It is a full-time day program only.

## Registration for Classes

Once you are admitted you will be able to enroll in your classes for the semester. You are responsible for knowing the prerequisites for the classes that you wish to register. If you are signing up for a class for which the prerequisites have not been met at Nassau Community College, you will be required to contact the Chairperson of the department to get an override waiving the prerequisites.
