



Workforce Development & Lifelong Learning Programs ELIGIBILITY INFORMATION

Workforce development training courses, English language skills course and high school equivalency review courses are currently available for free through Nassau Community College's Office of Workforce Development and Lifelong Learning.

To be eligible for a scholarship, you must meet basic requirements including:

- Be an unemployed or under-employed Nassau, Suffolk, or Queens County resident
- Be at least 17 years of age
- Have earned a high school diploma or equivalent for workforce training opportunities*
- Have access to a computer and Wi-Fi (courses may have a remote learning components)
- Meet HUD income eligibility requirements (determination will be based on documentation provided with your application). Income eligibility is based on the number of members in your household and the total income of all the members of the household. Please submit your income documents after blacking out personal identification information such as a Social Security number.
